Tour prices include international round-trip airfare (unless "land Only" is selected), accommodations at the described hotels which include daily breakfast and dinner (some meals may be on your own), three meals a day at Tamar Park, sightseeing, transportation to various sites and to and from the airport (if departing with the group). Other arrangements can be made at the participant's own expense. If departure/return dates, or airports are changed by tour participant within 30 days of departure, and are allowed by the airline, there will be an additional fee. Cancellations must be made in writing by email, fax or letter. Prices are based on double occupancy. The single occupancy fee will be charged if a roommate is not available. Prices are subject to change based on rate increases for fuel and other unforeseen increases. Blossoming Rose is not responsible for airline schedule changes or financial liabilities due to strikes, acts of God, or other events that Blossoming Rose cannot control.

Cancellation Fees

Cancellations fees per person, based on the full tour price, are: 91 days or more = \$100; 90 – 61 days = 30%; 60 – 41 days = 60%; 40 – 30 days = 75%; 29 days or less = 100%. Refund may take up to 6 weeks.
